3. **WORKING AREA** : N.C.T. of Delhi.
4. **AIMS AND OBJECTIVES** : The aims and objectives of the society for which the same is established, are as under:-
- a. To create a sense of brotherhood co-operation, mutual harmony, love and affection amongst the members of the society and also amongst the general public.
 - b. To promote the cause of National Integrity and unity of India and to light against the forces of separatism in India.
 - c. To organize seminar on social justice, educational and economical upliftment of raise legal demands and fundamental rights provided by the Cultural of India.
 - d. To open, found, establish, promotes, set up, run, maintain, assist, finance support and/or help the various charitable, educational industrial technical/non technical, industrial, vocational, agricultural and community development programs for all and all over in India.

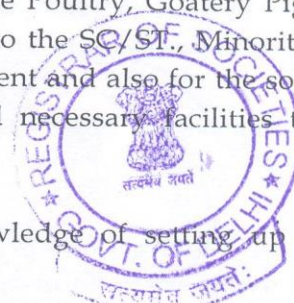
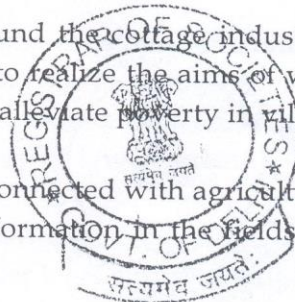
- f. To establish, maintain or grant aid for the establishment of maintenance of Wells, Tube Wells, Tanks, Water reservoirs, Trees and also to make the constructions maintenance of paths, roads, khandanja, parks, Sewerage and other building and institutions which are used by the general public.
- g. To take up effective but reasonable and lawful steps for the eradication of social evils such as Dowry system, Child Marriage (BAL VIVAH), Child labour, wastage of money is the various functions and use of intoxicated drugs/wine/smack etc.
- h. To help the street children by providing them shelter, food and education.
- i. To make adequate. Arrangements and start the rehabilitation centers for destitute, widows, old men and women, poor, beggars, handicapped, blinds deaf, dumb, mentally retarded and for other needy people.
- j. To organize, arrange and conduct programmes for the development welfare of downtrodden, depressed and exploited classes specially women and children of the humanity and to generate self - sufficiency, confidence and vitality among them.
- k. To take up effective but reasonable and lawful steps for the solution of the problems relating to the blind handicapped, mentally handicapped deaf dumb and other disabled through the various kinds of training programs and also providing them required facilities to make them independent.

To give, provide and/or render monetary and/or other help and assistance for the relief of persons and animals affected by natural and other calamities such as flood, fire, famine, cyclone, earth quake, storm, accident, pestilence drought, epidemic unbearable cost of living and the like, to give donations subscription or contributions to institutions establishments, centers on persons doing relief work on such occasion.
- m. To approach and to encourage the people to donate Dandies-Blacken progs, Woolen/Cotton/Silken Clothes and other articles of only use to the men women and children.
- n. To provide food, cloths, shelter (temporary/permanent), medicines and other required facilities to the people who have faced the natural clam the disaster.

- w. To start, establish, promote, maintain, found the cottage industries, in the rural area under governance of the society in order to realize the aims of women empowerment, self employment to the village youths and alleviate poverty in villages.
- x. To approach the farmers (and the people connected with agriculture) and provide them the latest technology and the research information in the fields of agriculture for the betterment of farmers/agriculturists.
- y. To start, run and manage the various training centers like Poultry, Goatery Piggery, fishery etc. to train the young boys and girls belonging to the SC/ST, Minority and Backward Classes for the purpose of getting self employment and also for the solution of the problems of unemployment and also provide all necessary facilities to the trainees.

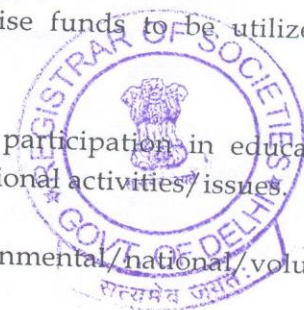
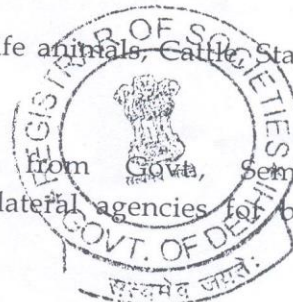

- zz. To collaborate, co-operate, and co-ordinate with governmental/national voluntary organization, working in the field/areas mentioned above.

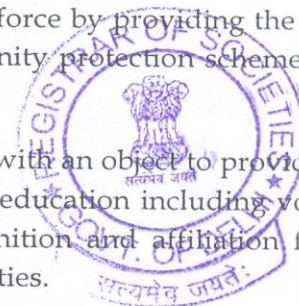
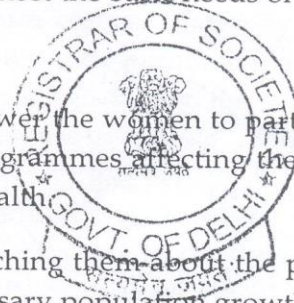

To establish, run, maintain and grant aid in cash or kinds to Advance Technical education colleges including Engineering & Diploma College, G.R.C., Management Education Institute, Computer Science & Engineering Institutes, Teacher Training and Specialized studies & Research Institutes Science and Technology to provide standard and high class education for B.E./B.tech /B.Arc/MBA/B.Ed./M.Ed./N.T.T. courses and other related courses to the student according to Rules and Regulations of A.I.C.T.E., N.C.T.E. and State Government.
